- 1: Jurisdiction:** Held under the National Sporting Code, Environmental Code and Standing Trials Regulations of the TVTC & Star Group, these Supplementary Regulations and any final instructions issued.
 - 2: Eligibility:** Open to licensed members of the ACU driving solo & sidecar trials motorcycles.
 - 3: Entries:** Send form to the Secretary of the Meeting with an entry fee of **£20 Adults, £25 Sidecar, £15 Youth**. Open forthwith, Entries for Star Group close on **6th December 2017**; TVTC close on the day.
All entrants must show ACU licence at signing on. Cheques payable to **Witley & DMCC**.

 - 4: Medication:** It is your responsibility to declare at signing on if you are on medication.
 - 5: Course:** 3/4 Laps of 12/15 Sections, without roadwork. A Special Test may be used to decide ties.
 - 6: Refuelling Area:** **It is a condition of entry that the refuelling of all motorcycles must only take place in designated refuelling area. Spillage mats will be provided and must be used.**
